## **START/END DATES:**

Entries for The Bill and Peggy Britt Scholarship Program Competition (the "Britt Contest") will be accepted, beginning 10:00 am Eastern Time ("ET") November 18, 2024 through 11:59 pm ET April 30, 2025 (the "Promotion Period").

#### **ELIGIBILITY:**

The Britt Contest is open to Amway North American IBOs (to include, Amway Corp., Amway Canada Corporation, Amway Dominican Republic and Amway de Puerto Rico) ("Sponsors") who are legal residents of the United States, Canada, the Dominican Republic or Puerto Rico. An IBO must be active and in good standing as of 10:00 am ET, November 18, 2024 to enter and participate. The Scholarship Program is also open to the children of IBOs; in this case, the parent IBO must be active and in good standing as of 10:00 AM ET, November 18, 2024, for their child to enter and participate. IBOs and their children who apply must be registered students enrolled in a trade school or technical school, community college, four-year degree program or master's degree program.<sup>1</sup>

Employees, officers and directors of Sponsors and their respective parent companies, subsidiaries, affiliates, partners, advertising and promotion agencies, manufacturers or distributors of Britt Contest materials, and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such

employees/officers/directors are not eligible to enter. The Britt Contest is governed by U.S. law and is subject to all applicable federal, state and local laws and regulations.

Members of the Judging Panel (as defined below) and their immediate families (parents, children, siblings, spouse) or members of the same household (whether related or not) of such individuals are not eligible to enter. All federal, state and local laws and regulations apply.

#### **HOW TO ENTER:**

To enter, an applicant (IBO or the child of an IBO) must prepare and submit an
original essay that shares a personal story of how they have helped improve the
lives of others.

Essays must be between 350 words and 500 words and submitted electronically, online at https://amway.com/en\_US/britt-scholarship. Hard copy submissions will not be accepted.

All submissions must include the entering IBO's name and IBO number; for an entry submitted by the child of an IBO, the submission must include the parent's IBO number.

All applicants must have a valid email address.

Sponsors reserve the right to cancel or modify this Britt Contest in the event an insufficient number of entries are received that meet the minimum judging criteria. Only one entry will be accepted per person. In the event multiple entries are submitted for a single person, only the first received<sup>2</sup> will be accepted for consideration in the Britt Contest. All others will be destroyed.

Sponsors and judges reserve the right, in their sole and absolute discretion, to disqualify and reject any entries that are inappropriate for any reason, including without limitation, for containing profane or inappropriate language.

No automated entry devices and/or programs permitted. Sponsors are not responsible for lost, late, illegible, stolen, incomplete, invalid, unintelligible, misdirected, technically corrupted or garbled entries, which will be disqualified, or for problems of any kind whether mechanical, human or electronic. Only fully completed entry forms are eligible. Proof of submission will not be deemed to be proof of receipt by Sponsors.

By entering, each applicant warrants and represents the following with respect to her/his Submission: (a) applicant is the sole and exclusive owner of the Submission; (b) the Submission is applicant's own creation and is 100% original; and (c) the Submission will not infringe on any rights of any third parties; and (d) any third party whose person or property appears in the Submission has given applicant appropriate written consent

(which shall be provided to Sponsors upon request thereof) for such person or property to be filmed and used as permitted herein.

All submissions will become the property of Sponsors and will not be returned. By entering, applicant(s) and/or their parent(s) agree to the use by Sponsors and its designees of her/his name, photo and/or likeness, statements and other personally identifiable information in any advertising and/or promotion in any and all media now or hereafter devised worldwide in perpetuity, without further compensation, notification or permission except where prohibited.

Submissions may be cut, edited, reformatted, rearranged, combined with other materials and/or otherwise modified, in Sponsors' sole and absolute discretion.

## JUDGING:

One finalist will be selected from the entries received during the Promotion Period, by a panel of independent and unaffiliated professionals working in the not-for-profit and philanthropic fields. Each Submission will be judged based on the following:

- Relevance
- Emotiveness
- Impact

The finalist will be notified of their selection by electronic mail, mail and/or telephone, on or around June 2025. It is the applicant's sole responsibility to notify Sponsors if they change their contact information.

By entering the Britt Contest, applicant(s) and/or their parent(s) fully and conditionally agree to be bound by these rules and the decisions of the judges, which will be final and binding in all matters relating to the Britt Contest.

#### PRIZES:

The Britt Contest winner will receive a check in the amount of fifteen thousand dollars (US\$15,000). All costs and expenses related to prize acceptance and use not specified herein as being awarded are the responsibility of winner, including, but not limited to, all federal, provincial, state and local taxes (including income taxes).

Total value of Britt Contest: US\$15,000.

Prizes are awarded "as is" with no warranty or guarantee, either express or implied. U.S. IBOs will be awarded in U.S. currency; Canadian IBOs will be awarded in Canadian currency; Dominican IBOs will be awarded in Dominican currency. Sponsors reserve the right to substitute an award of comparable or greater value, at its sole discretion. All local, provincial, state and federal taxes on awards, and other costs and

expenses associated with award acceptance and use not explicitly stated herein as being provided, are the sole responsibility of individual winners. All award details are at Sponsors' sole discretion. Limit: one (1) award per person for the Britt Contest and the Founders Memorial Scholarship Contest.

### **WINNERS' INSTRUCTIONS:**

Winner will be required to complete and sign a Standard Release form (if Canadian) or an Affidavit of Eligibility and Liability and Publicity Release (if from the U.S.), where legal, and return it within 14 days of date of issuance. Failure to return all required documents properly completed and executed within the specified time period, Sponsors' inability to contact a potential winner within a reasonable time period, the refusal of a prize by a potential winner, the return of any prize as undeliverable and/or non-compliance with any portion of these Official Rules (including all eligibility requirements) may result in the selected winner being disqualified, the award being forfeited, and an alternate winner being selected, at Sponsors' discretion.

Winner will not be subject to backup withholding on payments received if the correct information is provided on Form W-9. If Winner is not a U.S. person, the appropriate Form W-8 needs to be completed prior to gift being awarded.

Any controversy or claim arising out of or relating to these Official Rules and/or the Britt Contest shall be settled by binding arbitration in accordance with the commercial arbitration rules of the American Arbitration Association. Any such controversy or claim shall be arbitrated on an individual basis and shall not be consolidated in any arbitration with any claim or controversy of any other party. The arbitration shall be conducted in the State of Michigan, City of Grand Rapids.

THESE OFFICIAL RULES AND THE INTERPRETATION OF ITS TERMS SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF MICHIGAN WITHOUT REGARD TO ITS CONFLICTS OF LAWS RULES.

For any matters which are not subject to arbitration as set forth in these Official Rules and/or in connection with the entering of any judgment on an arbitration award in connection with these Official Rules and/or the Britt Contest, the parties irrevocably submit and consent to the exclusive jurisdiction and venue of the state and federal courts located in or closest to the County of Kent in the State of Michigan. The parties agree not to raise the defense of forum non conveniens.
